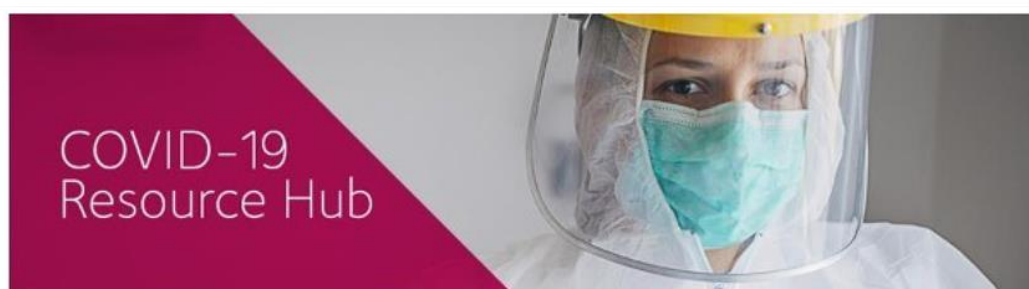

Federation ACO | MIPS Quality Score Results

In 2019, the Federation ACO earned a performance-based MIPS score of 95.6%

CMS recently reported our 2019 final Federation ACO Merit-based Incentive Payment System (MIPS) quality score is 95.6%. This is the third straight year in which our MIPS score has exceeded 95%. As a result, the MIPS payment adjustment for exceptional performance for Federation ACO participating providers will be 1.49%. Congratulations on this extraordinary accomplishment!

Zoom update | Passcode Requirement



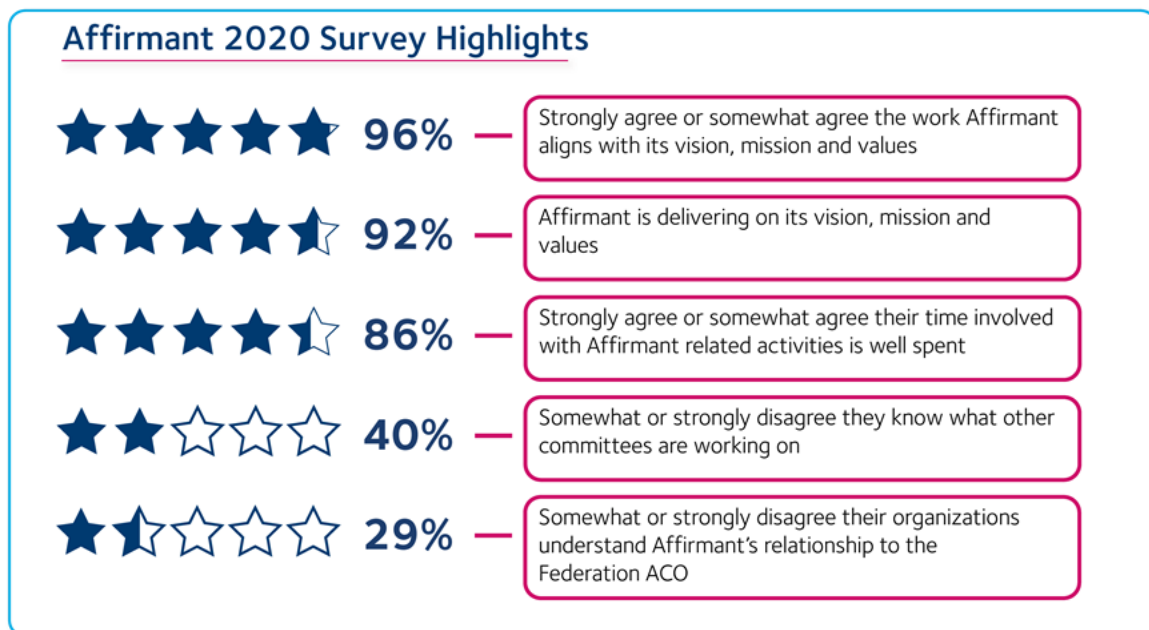

Affirmant 2020 Survey | Results

In January 2020, the Affirmant Team conducted a 22-question survey of our Board, Committee, Subcommittee and Workgroup members to measure satisfaction and solicit feedback on where we can make improvements. A total of 56 participants (41% of committee members) completed the survey; all seven Chapters and 12 Committees (Subcommittees and Workgroups) were represented in the results.

Quantitative highlights from the survey include:



Participants were also asked to respond to qualitative questions.

- When asked about Affirmant's greatest strength, participants commented on our network's scale and size, best practice sharing, common Epic platform and collaboration.
- When asked about Affirmant's greatest opportunity, themes included growth beyond our current Members, expanding our contracting strategy, accountability to each other, data integrity, enhancing collaboration and best practice sharing.
- When asked how Affirmant can improve its value to our network, respondents asked for greater involvement of practicing physicians, developing a stronger negotiating strategy with payers, improving data analytics and expanding best practice sharing.

Measures Development | 2020 Scorecard Approval

The Clinical Transformation Committee approved the proposed performance methodology for the Chapter Scorecard for the performance year 2020, which is similar to that approved for the 2019 Scorecard. In the event CMS provides further guidance related to quality and utilization measures for performance year 2020, the Measures Development Subcommittee (MDS) will consider appropriate changes to the Scorecard.

The Quality Measure Validation Team met in early August to review the documentation for the first six scored quality measures. The quality metric rules were evaluated and

documentation now contains diagnosis, codes and other groupers used to evaluate the rules that populate the Affirmant dashboards. The validation team will meet again on 9/2 to recommend standard definitions that will be brought to the Measures Development Subcommittee.
