
PHO Report

The monthly PHO Report has been delayed for the months of February and March due to issues with Meaningful Use reporting. Reports will resume in April.

Sullivan Luallin Update

We've received approximately 8,000 Sullivan Luallin survey responses over the course of six months. The overall response rate as of March 1st was 21 percent with 82 percent of patients completing all questions. This is compared to a total of 14,000 responses over the two year period with Arbor Associates (2014-2015). The scores are consistent with Arbor data.

- Survey Demographics
 - Majority of respondents are 45+ (74%)
 - Lowest response rate from ages 18-24 (1%)
 - 33% of respondents have been seeing the provider they surveyed for six months or less
 - Respondents seeing their provider for five or more years are the second largest group (24%)



- New questions in updated CAHPS survey focus on "Providers' Use of Information to Coordinate Care" – see below:
 - How often did this provider seem to know the important information about your medical history?
 - When this provider ordered a blood test, x-ray, or other test, how often did someone from this office follow up to give you results?
 - Did you and anyone in this provider's office talk at each visit about all the prescription medicines you were taking?

We will be reaching out to those who have not begun the survey process and work with practices to improve email collection and response rates.

Employer Services

Lakeland Care Network has teamed up with Be Healthy Berrien to help manage a \$50,000 state grant to support new or improved worksite wellness programs in the greater Niles area. The project is designed to help employers create sustainable worksite wellness initiatives through policy and environmental changes that will improve the health of their population.

A worksite wellness toolkit has been developed to help employers. The 20 worksites will receive technical assistance and a stipend to implement a worksite wellness policy and environmental changes that support physical activity. In order to qualify for the program, organizations must employ members of the target population with one third of worksite employees earning less than \$13.32 per hour.

"The first project aims to work with 20 work sites to help employees be more physically active through the workday," said Heather Cole, Be Healthy Berrien coordinator.

As an expert in employee wellness services, Lakeland Care Network will play an integral role in the support and implementation of the grant.

Lakeland Care Network has contracts with four Medicaid Health Plans: Meridian Health Plan, United HealthCare's Community Plan, McLaren Medicaid, and Priority Health Choice. Cigna's State of Illinois Claims

The State of Illinois has not passed a 2015/2016 budget and therefore has stopped funding payment of claims for the Quality Care Health Plan/State of Illinois retiree's membership, account #3181456. Their ID cards look like this:

This lack of funding means they are not paying for services provided by our physicians and hospitals for their members. This lack of action on the part of the Illinois legislators has created a non-compliance issue in our contract with Cigna. LCN physicians may now require payment at the time of service and bill patients for any unpaid, historical claims. The decision to do so is up to each individual physician/practice.
